We are again asking permission to hold a Trivia Parade prior to the 2015 Trivia Contest on WWSP 90FM radio. We will again be registering teams in advance at the 90FM studios, and will ask Trivia teams to be in the parade on April 17. We would like to start the parade at 4:00 P.M. in the parking lot on Illinois Avenue (lot Q). The route that the parade would follow would be the same as last year, it follows:

Illinois avenue north to Maria Drive, Turn left.
West on Maria Drive to Isadore Street, Turn left.
South on Isadore Street to Portage Street, Turn left.
East on Portage Street to Phillips Street, Turn right.
South on Phillips Street to College Avenue, Turn left.
East on College Street to Reserve, Turn left.
North on Reserve to High Street, Turn right.
East on High to Fremont Street, Turn right.
South on Fremont to Simms Avenue, Turn left.
East on Simms into the P.J. Jacobs parking lot.


