I am writing to request a special permit for the purpose of being able to raise chickens within the Stevens Point city limits. My wife and I currently live at 1108 Green Ave, on a 1.98 acre lot. We currently have a garden, fruit trees, and like to get as much of our food fresh and local as possible. We have a family of seven and would like to add fresh eggs to the items we have available. We also have heard that chicken waste is very beneficial for composting and we plan to add it to our compost pile and our garden.

Criteria for the city ordinances:


As for the security and maintenance of the chickens...Currently, we are in the process of fencing in the front and sides of our property to increase security for our children. This will also aid in the safeguards for the chickens. In addition to this, the chickens will be kept at all times in an enclosed coop/run within my backyard and will never be allowed to free run. The coop that we chose can hold between 6-8 chickens (I am including the plans) and we will stay within those limits. We have 5 kids (as well as my wife and I) that will be in charge of cleaning and maintaining the coop on a regular basis. Coop will be cleaned regularly and chickens will be fed/watered daily. In addition, We will NOT be getting a rooster, but hens only so there should be minimal noise. We have checked with 3 of our closest neighbors and they are supportive of the chickens and have even requested eggs! I am enclosing their consent. None listed concerns.
