**ORDINANCE AMENDING THE REVISED MUNICIPAL CODE OF THE CITY OF
STEVENS POINT, WISCONSIN**

The Common Council of the City of Stevens Point do ordain as follows:

SECTION I: That Section 12.14(18) of the Revised Municipal Code is hereby **amended** to read as follows:

(18) Application Due. Applications for Class “B” picnic licenses must be made not less than ~~ten (10)~~ four (4) days prior to granting of the licenses. Applications for “Class B” temporary wine licenses must be made not less than fifteen (15) days prior to granting of the licenses.

SECTION II: This Ordinance shall apply to all applications for Class B picnic licenses on file as of May 27, 2011 and take effect upon passage and publication.
