Special Olympics Wisconsin State Summer Games will be held this year on Thursday, June 7 thru Saturday, June 9 on the University of Wisconsin - Stevens Point campus.

To provide for the safety of the participants and other visitors, the Special Olympics Summer Games Committee would like to close Reserve Street from Maria Drive south to Fourth Avenue and also would like to close Illinois Avenue from Maria Drive south to the entrance of UWSP's parking lot Q. We would need to close Reserve Street at 8:00 p.m. on Wednesday, June 6th to provide adequate time and space for the production equipment to begin setup early Thursday morning. We would need to close Illinois Avenue at 5:00 p.m. on Thursday, June 7th. The roads would remain closed until 3pm on Saturday, June 9th.

Throughout the games, semitrailers, classic cars, and other display items will be setup on the west side of Reserve Street. The east side of the street would contain no displays and still be accessible by emergency vehicles if necessary.

Our games management committee is hopeful we can work with the City of Stevens Point's Streets Division to arrange the delivery of barricades. After delivery, the committee will take responsibility for set-up and remove of them.
