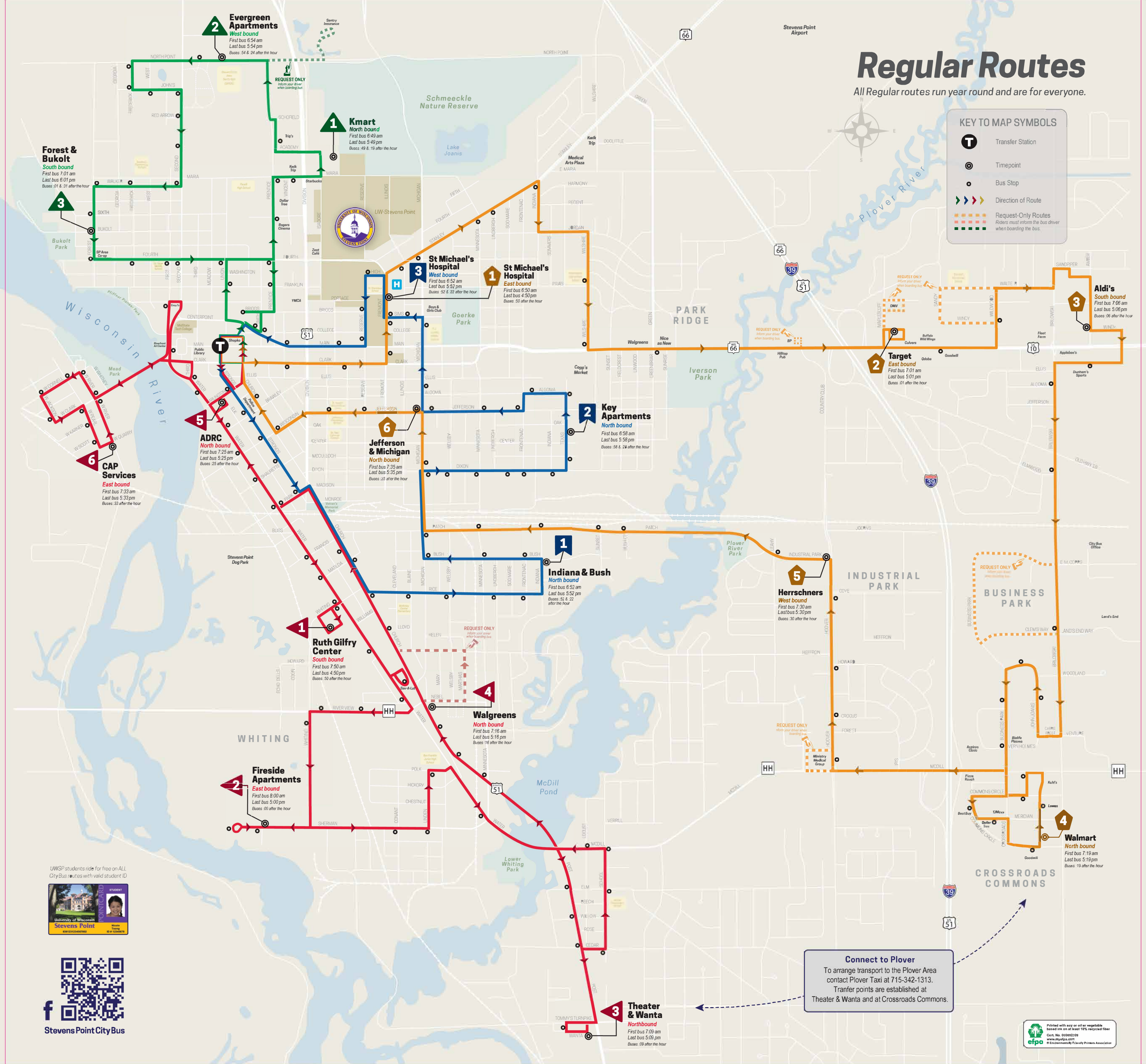


Regular Routes

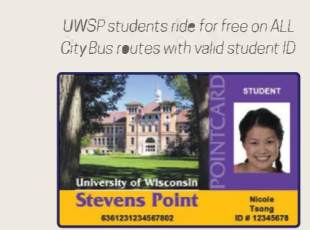
All Regular routes run year round and are for everyone.
