SIDEWALK REPAIR ORDERS:

This is part of the city's ongoing sidewalk inspection and repair program. The city is divided into five areas whereby a section is inspected every five years.

The inspector prepares a list of property owners who have sidewalk that needs to be repaired or replaced. The Engineering Department presents this list of property owners to the Board of Public Works and Common Council for approval. After Council approval, the property owners will be notified and the list published as Pursuant to Section 66.0907 of the Wisconsin Statutes.

The property owner will receive orders, a copy of the City Ordinance, price estimates from the last 10 years along with a letter that explains that they have until October 31st of 2014 to repair or replace their sidewalk on their own if they elect to do so. If they simply choose to do nothing, the City's sidewalk inspector will put them on the sidewalk repair contract that will be bid the spring of 2015 and their sidewalk will be replaced that summer by the City's lowest contracted bidder. They will pay only the actual cost of replacement, if it is over \$100.00; they have the option of spreading the cost over a total of three years. The letter tells them they can call the Engineering Department if they have any questions.

The inspector will go out early in the spring after the snow melts and compile the list of property owners that chose to let the City repair the sidewalk for them. These properties will be placed on the 2015 sidewalk repair contract. He will also inspect the sidewalks that were repaired or replaced by the property owner to make sure they are up to standard.

If complaints are received about damaged or bad sidewalk in other areas in time to be placed on this list they are included. If not in time, and if the inspector thinks they are bad enough, they will be brought to the Board of Public Works individually or placed on the list for the following year.

1. Engineering Division

- **Business 51 Project:**

No items to report on this month.

- **Bukolt Avenue: (Front Street – Second Street)**

Underground utility work started on Tuesday, July 15th at the intersection of Georgia Street and Bukolt Avenue and began working west. The contractor has all of the water main and sanitary sewer main, including laterals, installed up to Front Street. The contractor is currently installing storm sewer in this same block including a 250 linear foot section of 42" storm sewer between Bukolt Avenue and Fifth Avenue. Up to this point the contractor has not encountered any rock that has required blasting and this has allowed the project to get off to a good start.

- **Fire Station #1:**

The general contractor has finished all remaining punch list items and delivered O&M Manuals per the contract and the final retainage payment will be sent out.

- **Strong's Parking Lot:**

The parking lot is finished and we will begin collecting quotes for snow removal services for the upcoming winter season.

- **North Second Street and Maria Drive Property Acquisition:**

We are currently in the negotiation process.

The Environmental Report (30% design) has been submitted to DOT. Dates and timelines have also been established in order to have a 2017 construction timeline.

- **Additional Ongoing Director\City Engineer\City Surveyor Projects:**

1. Rocky Run Bridge Deck Epoxy Overlay Project #14-09: The City of Stevens Point owns and consequently maintains the structure that crosses the Rocky Run Spillway. I have included an aerial photograph to show where this structure is located. The bridge deck is starting to show signs of bigger than hairline surface cracking and should be addressed. The work will consist of basically a chip seal for bridge decks. However, an epoxy resin is used instead of oil emulsion.
2. Fall Paving Project #14-10: The City will be bidding the paving of the parking lots and internal roads at Iverson Park, the trail between the Willett Ice Arena and the Parks Department Building, along with a short section of the trail at Mead Park. The City will also include in the project a Black Knight Paving Armor adjacent to the Post Office on Main and Smith Streets and the intersection of Prentice Street and Schofield Avenue.
