3. Response letter from Portage County dated December 11, 2017 regarding its investigation of Emergency Management Director Joe Brandt 's conduct

The commission has had time to review the response letter from Portage County Executive Patty Dreier regarding the PFC's investigation into matters detailed in a letter addressed to Patty Dreier dated November 11, 2017. It was Commissioner Wescott's intent at some point to have a detailed review of Portage County's response in comparison to the findings of the city's investigators.

However, the commission believes that in light of the recent development of the resignation of Portage County Emergency Management director Joe Brandt, a line by line item review of Portage County's response becomes a moot point.

A discussion followed and President Wescott afforded the commissioners an opportunity to voice any thoughts or concerns. Several commissioners noted that no one from the city's fire service, attorney's office, mayor's office or police and fire commission were interviewed by the county during the county's investigation. The commission reserves the right to revisit this matter at greater length. President Wescott thanked County Executive Patty Dreier for implementing a plan to investigate the city's concerns.

Commissioner Wescott moved, seconded by Commissioner Kirschling, to acknowledge receipt of the county's response (dated December 11, 2017) to the city's November 8, 2017 letter and place the letter on file. The Commission additionally stipulates that by placing the letter on file the commission is also going on record stating they do not necessarily concur with all the findings contained in the county's response.
