

City of Stevens Point Meeting Minutes

Reorganization Meeting of the Common Council

Tuesday, April 21, 2009

2. Mayoral Appointments to Various Boards and Commissions. List of Boards, Commissions

Ald. Trzebiatowski asked why the Aldermanic position on Plan was not placed on the agenda as an election by the body.

City Attorney noted that in 2000 the ordinance was changed to a regular appointment by the Mayor. For some reason it was not followed in 2003 and 2006.

Ald. Stroik moved, Ald. Wiza seconded, to approve the Mayoral Appointments to Various Boards and Commissions. Ayes, all; nays, none; motion carried.

3. Mayoral Appointments of Council Members to Standing Committees. List of Standing Committees

Ald. Molski moved, Ald. O'Meara seconded, to approve the Mayoral Appointments of the Council Members to the Standing Committees. Ayes, all; nays, none; motion carried.

4. Nominations and Election of President of the Council.

Mayor Halverson called for nominations for President of the Common Council.

Ald. Brooks nominated Ald. Stroik.

Mayor Halverson called for any further nominations and hearing none he closed nominations.

City Attorney Molepski suggested that, unless there is an objection, the motion be amended to direct the Clerk to reflect that a unanimous ballot was conducted and the results indicated that Alderman Stroik was elected President of the Common Council.

Amended Motion: Alderman Brooks nominated Alderman Stroik for President of the Common Council and that the Clerk is directed to reflect that a unanimous ballot was conducted and the results indicated that Alderman Stroik was elected President of the Common Council.

Mayor Halverson congratulated the new alderpersons and Alderperson Stroik.
