

BOARD OF CANVASS

APRIL 11, 2016

PRESENT: City Clerk John Moe; Mary Ann Bieno, Marge Molski.

**District #2,**

Wards 4 & 5: There were 932 voters with 930 ballots recorded. Two individuals left without voting. David Shorr received 347 votes; Denise Mrozek received 258 votes.

Ward 6: David Shorr received 45 votes; Denise Mrozek received 29 votes; 1 write in Candidate.

**District #4:**

Ward 10: There were 175 voters, 16 absentees.

Ward 11: There were 530 voters, 47 absentees.

Ward 12: There were 120 voters, 7 absentees.

**District #6:**

Ward #16 Voters 1,094; absentee ballots 104; printout revealed 1,093 ballots, 1 less ballot than voter is acceptable.

**District #8:** Voters 1,108; absentee 114. A draw down was done because there was an extra Ballot which only affected the presidential.

**District #10:**

Wards 28 & 29: There were 689 voters, absentee ballots were 50. Mike Phillips received 371 votes; Robert Larsen received 174 votes.

Ward 30: There were 214 voters; 34 absentees. Mike Phillips received 120 votes; Robert Larson received 45 votes.

**LATE ARRIVING ABSENTEE BALLOTS**

**District 2, Ward 5:**

There were 2 absentee ballots which were confirmed as acceptable. Voter numbers were recorded as #847 and #848. The results were:

Voter #847: one vote each: Clinton, Kloppenberg, Baker, Dobretz, Shorr, Faxon, Suomi.  
Voter #848: one vote each: Cruz, Bradley, Shannon, Dobretz, McKenna, Shorr.

**District 3, Wards 7 & 8:**

Two absentee ballots were received and were confirmed as acceptable. Voter numbers Assigned were #711 and #712 and the results were:

Voter #711: one vote each: Sanders. No other votes cast .

Voter #712: one vote each: Cruz, Blanchard, McKenna. No other votes were cast.

**District 4, Ward 11:**

One ballot was confirmed as acceptable. The results were:

One vote each for: Sanders, Kloppenberg, Blanchard, Baker, Medine, Oberstadt, Daley, Suomi, Konas, Erick Sheets unregistered write-in.

**District #5, Wards 14 and 15:**

There was one ballot confirmed as acceptable. The results were:

One vote each: Sanders, Kloppenberg, McKenna, Suomi, Kontas, Protzen. No other votes were cast.

The meeting was recessed at 10:48 and reconvened at 10:53.

**District 6, Wards 16-18:**

There were 3 ballots received. One ballot did not have a signature on the envelope and Rejected. The 2 remaining ballots were confirmed as acceptable. The results were:

Ballot 1: one vote for: Cruz, Kloppenberg, Blanchard, Shannon, Dobretz, McKenna, Slowinski, Daley, Ebel, Suomi, Portzen.

Ballot 2: one vote each for: Cruz, Bradley, Blanchard, Shannon, Dobretz, McKenna, Slowinski, Daley, Faxon, Suomi, Portzen.

**District 7, 19-20, 21:**

There were 2 ballots received and both were acceptable.

Ballot #1 (ward 20): one vote each for: Sanders, Kloppenberg. No other votes were cast Counted.

Ballot #2: (ward 21): one vote each for: Sanders, Kloppenberg, Blanchard, Baker, Flood, McKenna, Portzen. No other votes were cast or counted.

**District 8, Wards 22-24:**

Three ballots were received and all confirmed as acceptable.

Ballot 1: one vote each for: Trump, Bradley, Blanchard, Shannon, Sipiorski, McKenna, Patton, Ebel, Suomi, Kontos, Portzen. No other votes were cast or counted.

Ballot 2: one vote each for: Clinton, Baker, Dugan. No other votes were cast or

counted.

Ballot 3: one vote each for: Trump, Bradley, Blanchard, Shannon, Sipiorski, McKenna, Dugan, Ebel, Suomi, Kontos, Portzen. No other votes were cast or counted.

**District 9, Wards 25-26, 27:**

Ward 26: Ballot 1: one vote each for: Sanders, Kloppenberg, Blanchard, Baker, Medine, McKenna, Daley. No other votes were cast or counted.

**District 10, Ward 28-30:**

There were 3 total absentee ballots received for District 10. All were confirmed as acceptable.

Ballot 1 (Ward 28-29): one vote each for: Cruz, Bradley, Blanchard, Shannon, DeDeker, McKenna, Larson, Ebel, Suomi, Kontos, Portzen.

Ballot 2 (Wards 28-29): one vote each for: Trump, Bradley, Blanchard, Shannon, DeDeker, McKenna, Larson. No other votes were cast or counted.

Ballot 3: Ward 30): one vote each for: Trump, Bradley, Blanchard, Shannon, Dobretz, McKenna, Phillips, Daley, Ebel, Kontos, Portzen. No other votes cast or counted.
