The 2012 Point Bock Run is scheduled for Saturday March 3, 2012 with a noon start time.


We have appreciated the city's assistance and support which has helped make our race successful as last year we reached our cap of 2,000 entries.

We are requesting permission to use the same route for the Point Bock Run that we have used the last three years and have the following road closures and parking restrictions implemented.

- Close Water Street from Francis Street to Matilda Street at 8:00 am for the start/finish area setup and keep it closed until 3:00 pm.
- Divert Water St. traffic onto Williams St. from noon to 1 p.m.
- Close West River Drive from County Highway HH north to West Mapleridge Drive between noon and 1 p.m.
- Parking be prohibited on Water Street from Francis Street south to Whiting Avenue, and Whiting Avenue from Water Street to County Highway HH. We request that temporary "no parking" signs be installed for the morning of March 3rd and removed by early afternoon.

We believe these road closures and restrictions on parking will make the race course safer for all runners and spectators involved.

Dear Mr. Moe,

UWSP Adventure Tours (a program of the school of Health Promotion and Human Development) would like to propose a new community event called Ciclovía Wisconsin. This event would be a free open-to-the-public bike/pedestrian loop around the north side of Stevens Point. Following the lead of similar events in Bogota, Columbia, Portland, OR, New York City, and Madison this statewide event will include safe transport through part of the city on roads closed (or specific lanes closed) to cars, "active" rest stops such as Zumba or Yoga classes, live entertainment, kids zones, vendors (local & Midwest), bike safety and demos, and more. The proposed date/times are Saturday, Sep. 22, 2012 from 10am-2pm, which has been cleared as an available community event date by the Stevens Point Area Convention & Visitor's Bureau.

The main goal of the event is to get people active while exploring the City of Stevens Point. For free, participants can join in the fun of travelling this looped route by riding their bike, walking, jogging, pushing a stroller, by wheelchair, rollerblading, etc. It will be a great way to get families out of the house, enjoy a fun, active, and wellness event, and patronize businesses along the way.

Safety is an important focus in developing this event and important measures and guidelines will be followed to ensure the safety of all participants, bystanders, and drivers (cars nearby or crossing the route). I have met with Sergeant Tim Davey and talked with Chief Kudronowicz of the SPPD to discuss logistics, safety, and routing for this event. Police will be utilized at critical & high traffic crossings, volunteer crossing guards will be positioned at less dangerous crossings, signage will navigate the participants through the route, signage will navigate cars around the route or safely across it, emergency routes will be planned within the route and crossing the route, road closings and detours will be governed by the WI DOT – TGM 13-10-1, and signing for special events will be governed by WI DOT – TGM 13-10-2. Strong event promotions through many forms of media will also increase the safety of participants, bystanders, police, volunteers, businesses, and the like.

The proposed route is an 8.8 mile loop around the north side of Stevens Point connecting the downtown Main St. to the north side of the City. The route includes the beauty of Pfiffner Park, Bukolt Park, Schmeckle Reserve, and the Green Circle Trail. The route will also include the UWSP Campus, Sentry Insurance, the dense business areas of Division, Main St., and the downtown square. There is no start or finish to the route as it is a loop that anyone can enter at any point along the 8.8 miles. The route was selected based upon safety, limiting disruption, business front exposure, scenery, and diversity.

Three main types of intersections will be differentiated based upon amount of traffic, speeds, complexities, location, and other variables. These three types of intersections are labeled as "Police Intersection", "Volunteer Intersection", and "Barricades Only Intersection" on the route proposal and will be controlled by said titles. This route will require approximately 32 intersection volunteers, 8 safety volunteers (on bikes), 4 info station volunteers, 6 activity station volunteers, and at least 20 setup/teardown volunteers. The route will also require about 9 contracted officers, many cones and signs, and at least 6 unmanned barricades. *Please see the attached map & proposed route for reference. An alternative/detour route map will be created upon approval of event proposal.*

Specific road closures on Sep. 22, 2012 from 10am-2pm would include: Old Wausau Rd. (Rachick Rd. intersect. to DuBay Ave. – 1.17 mi.), DuBay Ave. (Old Wausau Rd. to Johnson Dr. – 0.69 mi.), 2nd St. N. (Johnson Dr. to DuBay Ave. over the interstate – 0.27 mi.), DuBay Ave. (2nd St. N. to Reserve St. N. – 0.79 mi.), Reserve St. (DuBay Ave. to Northpoint Dr. – 0.77 mi.), Northpoint Dr. (Reserve St. N. to Wood Ln. – 0.88 mi.), part of Michigan Ave. N. (southwest corner of Lake Joanis to Maria Dr. – 0.04 mi.), Maria Dr. (Michigan Ave. to Division – 0.51 mi.), Division (Maria Dr. to Main St. – 0.72 mi.), Main St. (Division to Water St. – 1.3 mi.). Final determination of full road, partial road, and lane closures will be evaluated with the various municipal depts (Engineering, Fire/EMS, Police, etc.).

UWSP Adventure Tours will lead the event coordination and development with help from local partners – Active Portage County, Stevens Point Area Convention & Visitors Bureau, County Executive Patty Dreier, and more... Upon approval, I will also setup a volunteer committee to plan and organize this event for use of best practices and expanding event resources. I'm estimating there will be between 250-600 people participating throughout this event in 2012 and it will hopefully grow to be as large (or larger than) Walk Wisconsin.

I believe this event will serve the general public interest reflected in the main goal above and the event will not cause safety or capacity problems. With support from the City of Stevens Point I will work with local municipal departments (Engineering, Fire/EMS, Parks/Rec/Forestry, Police, etc.) in finalizing the event route, planning for emergencies, and other logistics, and I will apply for a special event permit through the WisDOT Regional office.

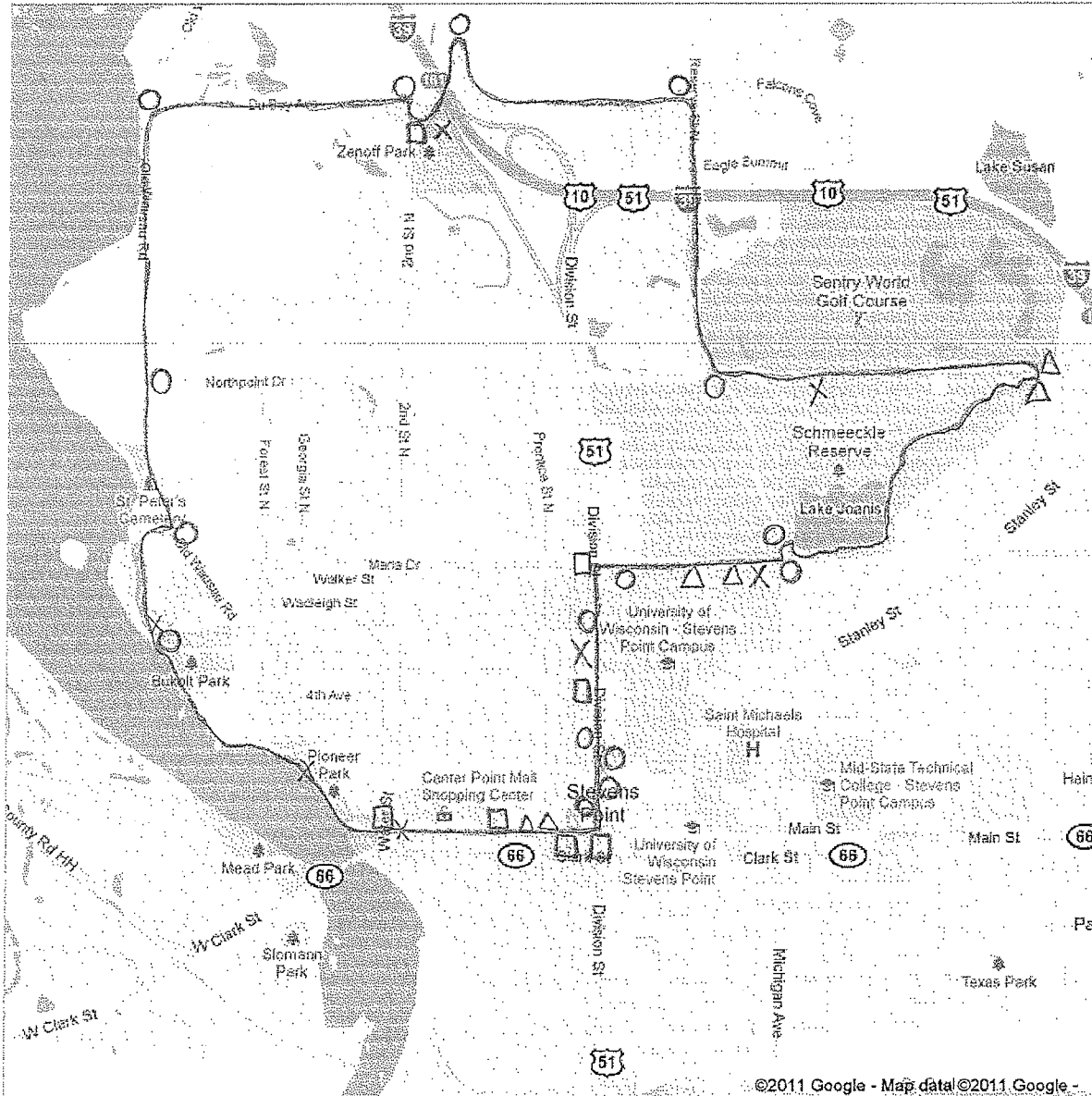
