(p) PARKING METER ZONES AND CONTROL

(1) Definitions.

A. Multi-Space Kiosk. A multi-space kiosk refers to a parking meter for a parking zone in which there is space for more than one vehicle to park. Multi-space kiosks shall be placed behind and adjacent to the curb within the parking zone such multi-space kiosk shall control. Where a multi-space kiosk has been installed, every vehicle shall park adjacent to the curb or angled to the curb as indicated by pavement striping in the zone controlled by the multi-space kiosk. Every vehicle operator shall deposit in the kiosk the appropriate form and the required amount of payment for the time the vehicle operator intends to park, up to the maximum time limit available. Unless otherwise specified or directed by a multi-space kiosk's instructions, each vehicle operator parking in a zone controlled by a multi-space kiosk must enter the identification number displayed on the vehicle registration plate issued for the parked vehicle and displayed on it in accordance with Wis. Stat. 341.15. Enforcement of parking zones controlled by

multi-space kiosks shall be via reference to a database of such identification numbers which identifies which location and period of time for which parking has been purchased for the vehicle thereby identified.

B. "Parking Meter" means any mechanical or electronic device or meter placed or erected for regulation of parking and designed to accept payment for parking privileges.

C. "Parking Meter Space" means a space officially designated for vehicular parking indicated by painted lines or other markings or dividers for which payment via a parking meter is required to lawfully park a vehicle.

(2) Payment to be deposited in Meters. No person shall stop, stand, or park a vehicle in a parking meter space unless payment has been made via a parking meter applicable to that space and the allotted time thereby purchased has not elapsed. Failure to comply with this provision is a violation of this code.

(3) Presumptive Violation. The fact that the timing device on any parking meter is not in operation and the mechanical indicator registered "Expired" or "Violation" shall be presumptive evidence that the owner or driver or the vehicle then parked in the space regulated by such parking meter failed to deposit or caused to be deposited the required coin or coins. For Parking meter spaces controlled by a multi-space kiosk, enforcement shall be via automobile registration number as identified in Wisconsin Statutes ch. 341. Drivers shall utilize a multi-space kiosk to purchase parking time prior to or immediately after parking in a space controlled by that kiosk. During that purchase, the driver shall

enter the identification number on the license plate affixed to the vehicle to be parked. If the database associated with the multi-space kiosk indicates based on a displayed license plate that no parking time has been purchased for the vehicle or that the purchased time has elapsed, it shall constitute presumptive evidence that the owner or driver or the vehicle then parked in the space regulated by such has parked in violation of subsection (p)(2) of this ordinance.

(4) Prohibited Parking. No person shall permit a vehicle registered in his/her name to remain in any parking meter space while the parking meter shows a violation or expired.

(5) Public Works Department to Install Meters. The Public Works Department of the City of Stevens Point shall procure, install, and maintain parking meters and mark off individual parking spaces in the parking zones as designated herein and in such other zones as may be hereafter established by the Common Council. Parking meter spaces shall be designated by lines painted or durably marked on the curbing or street surface. No person shall park any vehicles in a marked parking meter space so that the vehicle is not entirely within the limits of the space designated.

(6) Damaging Meters Prohibited. No person shall deface, injure, tamper with, willfully break, destroy, or impair the usefulness of, or open without lawful authority, any parking meter or multi-space kiosk. No person shall deposit or cause to be deposited in any parking meter any slug, device, or substitute for the proper coin.

(7) Maintenance, Collection Regulations. The Police Department and/or the Public Works Department shall employ personnel other than police officers as may be

necessary to service and maintain parking meters and collect the coins therefrom, and operate and maintain multi-space kiosks. All collectors shall be bonded in an amount set by the Common Council. A sealed or locked container shall be used as a receptacle for the collection of coins. Personnel employed in the service and maintenance of parking meters and collection of coins therefrom shall be under the direct supervision of the Traffic Officer and shall issue violation tickets or notices on forms prescribed by the Parking Meter Board, but shall have no powers of arrest.

(8) Disposition of Parking Meter Revenue. Parking meter revenue shall be deposited into the general fund of the city.

(9) Metered Zones and Lots Established: Time Limits.

A. Fifteen Minutes Parking Meter Zones. The following streets, and parts of streets are declared to be fifteen (15) minute parking zones and no person shall park, stop, or leave standing any vehicle in any parking space within such zones in excess of fifteen (15) minutes.

via appropriate signage and/or paint striping in such a manner as to reasonably inform drivers of which spaces the nearest multi-space kiosk controls.

(q) MISCELLANEOUS PARKING RESTRICTIONS.

(1) Street Maintenance. Whenever it is necessary to clear or repair a city roadway or any part thereof, the Street Department shall post such highways or parts thereof with signs bearing the words "No Parking-Street Maintenance Work." Such signs

shall be erected at least two hours prior to the time that street maintenance work is to be commenced. No person shall park a motor vehicle in violation of such signs.

(2) Parking in Driveways. No person shall park or leave standing any motor vehicle in any private driveway without the permission of the owner or lessee of the property upon which such driveway is located, whether or not such driveway is posted to limit or restrict parking.

(3) Parking Heavy Vehicles in Residential Districts. No operator of a motor truck, truck-tractor, trailer, or semi-trailer or any other vehicle or combination of vehicles other than motorbuses weighing more than 6000 pounds shall park such vehicle on any highway other than a routed State Trunk Highway in any residential district except for such time as is reasonably necessary to facilitate the loading or unloading of the vehicle.

(4) Snow Emergency Parking Restrictions. Whenever the Mayor shall, by reason of heavy snow storm or blizzard, proclaim a snow emergency pursuant to section 66.325 of the Wisconsin Statutes, no person shall park, stop, or leave standing any vehicle upon the streets of any portions of the streets during the hours set forth in said proclamation.

(5) No motorized vehicles or large trailers are allowed to park or stand on the area established in Section 12.02 (2) Licenses and Permits for the Public Square - Farmer's Market.

(6) No Parking shall be allowed on the east side of Minnesota Avenue from a point 131 feet north of the intersection of Main Street to a point 111 feet south of the intersection of Prais Street when event no parking signs are in use.

(r) UNLAWFUL REMOVAL OF PARKING CITATIONS. No person other than the owner or operator thereof shall remove a city parking violation ticket from a motor vehicle.

(s) REMOVAL OF ILLEGALLY PARKED VEHICLES.

(1) Hazard to Public Safety. Any vehicle parked, stopped or standing upon a highway in violation of any of the provisions of Section 8.09, Section 9.01 or this Section 9.05 of this Code is declared to be a hazard to traffic and public safety.

(2) Removal by Operator. Such vehicle shall be removed by the operator in charge, upon request of any traffic officer, to a position where parking is permitted or to a private or public parking or storage premises.

(3) Removal by Traffic Officer. Any traffic officer after issuing a ticket-citation for illegal parking, stopping or standing of an unattended vehicle in violation of this Code, is authorized to remove such a vehicle to a position where parking is permitted.

(4) Removal by Private Service. The officer may order a motor carrier holding a permit to perform vehicle towing services, a licensed motor vehicle salvage dealer or a licensed motor vehicle dealer who performs vehicle towing services to remove and store such vehicle in any public storage garage or rental parking grounds or any facility of the person providing the towing services.

(5) Towing and Storage Charges. In addition to other penalties provided in this Code, the owner or operator of a vehicle so removed shall pay reasonable cost of moving, towing and storage. If the vehicle is towed and stored by a private motor carrier, motor vehicle salvage dealer or licensed motor vehicle dealer, actual charges regularly paid for such services shall be paid. If the vehicle is stored in a public storage garage or rental facility, customary charges for such storage shall be paid. Upon payment, a receipt shall be issued to the owner of the vehicle for the towing or storage charge.

(t) REGISTRATION RECORD OF VEHICLE AS EVIDENCE. When any vehicle is found upon a street or highway in violation of any provision of this code regulating the stopping, standing, or parking of vehicles and the identity of the operator cannot be determined, the owner as shown by the ownership registration of the vehicle supplied by the Wisconsin Department of Transportation, or a comparable authority of any other state, shall be subject to appropriate penalty.

(y) Exceptions to parking restrictions

1. The Mayor may, upon receipt of favorable written recommendation from the Chiefs of Police and Fire and the Director of Public Works, designate that public parking is permitted on any City street or portion thereof, where parking is otherwise prohibited or restricted by ordinance.

2. Any such designation by the Mayor may be for a period of periods of up to 24 hours, but no exceeding five consecutive days, upon public notice not less than seven days prior to the said period(s).

3. Such street(s) or portion(s) therefore shall be appropriately marked to indicated the designation, either by removal or covering of prohibitive or restrictive signs or replacement of same with permissive signs, and that such changes shall be in effect only during the designated period(s).

4. Notwithstanding the restrictions in subsections (1), (2) and (3), the Mayor and/or Director of Public Works, or in their absence the Chief of Police may allow parking not to exceed 8 hour in specified areas, where parking is otherwise prohibited or restricted by ordinance.

(z) Emergency Vehicle Parking Only:

1. On the east side of Second Street from Clark Street to a point 122 feet south of Clark Street.

(aa) Permit Parking. Except as herein permitted, no person may park, stop, or leave standing any vehicle in the following places unless authorized by permit issued by the City of Stevens Point or a designated representative.
