EXHIBITION REQUIREMENTS

CONDITIONS

The exhibit is juried by actual artwork. Online submissions/photos are allowed for jury if, for example, the artists lives out of the region. Please contact for further information about digital submission. The juror will select artwork according to his/her preferences in the process of creating a cohesive and interesting exhibit. **Not all artists will have artwork selected.** The purpose of the jury process is to select a manageable number of pieces from the large number of submissions. Work not selected may be submitted for a future juried exhibit.

- Artists 18 and older may submit up to **3 pieces of artwork.**
- **Attach name, title of piece, and price of piece (or NFS) to the back of each submission.**
- Artwork submitted must be new (within one to two years) and not have been previously exhibited at the RAC.
- **A non-refundable fee of \$10 for one submission, \$15 for 2 submissions & \$20 for 3 submissions** will be charged at the time of delivery (*cash or check only*).
- It is preferred but not required that your art be for sale. It is our aim to promote sales of your art!
- Any medium is accepted for jury.
- All artwork must arrive ready to hang or install. Pictures must be matted and framed with wire on the back to hang (saw tooth hangers on small frames-8x10 or smaller only). Thick, gallery style canvas does not require a frame, but must have wire to hang, edges should be finished. 3D artwork needs to be self-supporting.
- Due to gallery space constraints only one artwork measuring around 15 sq. ft. or larger may be submitted.
- Only neutral colored mats and neutral colored frames will be accepted.
- RAC hangs and displays all artwork. Special display requests by the artist need to be made in advance.
- Triptychs will be considered three submissions, diptychs will be two submissions.
- Artists are responsible for transportation/shipping costs for all artwork.
- The RAC and juror reserves the right to decline any artwork at their discretion.
- **RAC assumes the right to photograph artworks** on display for publicity, educational and archival purposes (including but not limited to: social media, print and website).
- **Work needs to be dropped off & picked up on the dates specified.** RAC is not responsible for work left beyond the pick-up date. Artwork not picked up will become property of the RAC and may be sold with full purchase price going to the RAC.

SALES

- Sales will be handled by the gallery staff members. It is our aim to promote sales of your art!
- Sale price includes a 30% commission fee retained by RAC on all art sales. Art from the exhibit sold as a result of viewing it first at RAC and within 3 months after exhibition, is subject to the 30% commission fee or a donation from the artist.
