**Please read this important message:** Mark your calendar if you are paying by installment; your tax bill is the only notice that will be sent! Please note that if you miss any payment, the entire unpaid tax balance will be delinquent and assessed a 1% per month interest charge from February 1<sup>st</sup> until the taxes are paid in full. In the event that your taxes remain delinquent after July 31<sup>st</sup>, Portage County may add additional penalties.

**Payment Options: Payment in Full or Multiple Payments (see coupons below)**

(Payment amounts are shown below your tax bill and on each coupon. These are the minimum amounts due, larger payments are accepted.) **Please note, tax bills that are mailed in will not be returned without a SASE.**

**There are now three coupons at the bottom of your tax bill**

**Coupon 1:** Payment in Full, on or before January 31 or First installment.

**Coupon 2:** Second Installment, on or before April 30

**Coupon 3:** Third Installment, on or before July 31



\* A star in this box means unpaid prior year taxes

**Delinquent Star** located under your parcel number on your tax bill is an indicator of prior year delinquency. If you believe that this star is an error or wish to pay any unpaid balance, contact the Portage County Treasurer at (715) 346-1348.

**Fraud Prevention - Refund Checks:** When you receive a refund check from our office, there is a 48-hour delay before the check will be available to cash or deposit. During this waiting period, we are validating the check to prevent fraud. To avoid a refund check, be sure that your check is for the exact amount owed. We reserve the right to refuse any check.

\*Fees: Transaction fees are charged and collected by GovTechTaxPro. All fees are subject to change – You can verify fees before you accept your payment.

**e-Check:**

Fees\*: \$1.50 transaction fee per e-check valued up to \$80,000

**Credit Card: (Most Major Credit Cards Accepted)**

Fees\*: 2.35% plus \$1.50 per transaction

**Tax Payments on Multiple Parcels Paid thru GovTech Website:** Search for your parcels by name or parcel number and pay with one check or credit card during the checkout process.

**Dog and Cat Licenses:** All pet licenses expire on December 31 each year. Late renewals and initial licenses purchased after 30 days of ownership will be assessed a late fee of \$5.00. You must bring in a rabies certificate each time you are licensing. All new pets must be licensed by 6 months of age. If you are not renewing your license because a pet has passed away, send us an e-mail: [Treasurer@stevenspoint.com](mailto:Treasurer@stevenspoint.com) or call (715) 346-1573.

Licensing can be done through mail by sending a self-addressed and stamped envelope along with your pet's rabies certificate and payment.

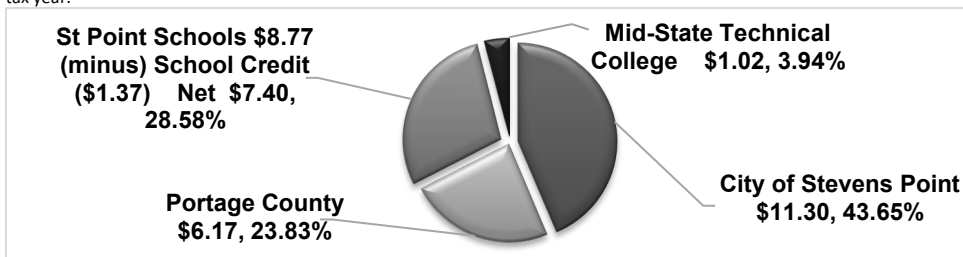
**Lottery Credit:** To qualify, you must own and occupy the property as your primary residence. You can only have one credit. Lottery Credit appears at the bottom of the tax bill above the Net Property Tax total. If there is an amount listed, you are receiving the lottery credit. If you feel you qualify, but are not getting the credit, please visit our website: [StevensPoint.com/LotteryCredit](http://StevensPoint.com/LotteryCredit). Complete form LC-100 and drop off to our office on or before the deadline of January 31. After this date, you will need to request a refund from the State of Wisconsin, with a deadline of October 1.

**Drop Box:** Located on the exterior of the building to the right of the Strongs Avenue entrance. Payments prior to 7:30am in the box will be receipted to the previous business day. **Enclose a self-addressed and stamped envelope if you would like a receipt mailed back to you.**

**Where your tax money goes:**

Tax Rate per \$1000 Assessed Value/Mill Rate = \$25.89 The tax rate increased \$0.75 per \$1000 assessed value.

\*If you receive the First Dollar Credit and/or Lottery Credit issued by the State of WI and placed directly onto your tax bill, please note that those credits are not reflected in the above tax rate. Please see your tax bill for any change from the previous tax year.
